

Subject: Important - New Belk Private Brand RFID Requirements

Dear Vendor and Agent Partners—

I hope that this finds you safe and healthy, and adjusting to a new normal during this time.

We have an exciting update to share with you. Belk is launching **RFID tagging** for all of our **Private Brand** products to improve our inventory accuracy and our order fulfillment. This is an important initiative, and will have tremendous impact in our stores and for our customers. However, we cannot embark on this initiative alone, and we need your help as our partners!

Mandate

Beginning with all **Private Brand June 2021 NDC orders** (all international orders placed on or after December 18, 2020), Belk will require all units to be **shipped with either a supplemental RFID hangtag or RFID sticker**.

- Belk is mandating that these supplemental RFID tags must be purchased from Avery Dennison
 - Avery Dennison will be set up to accept your RFID orders beginning December 18th
- Requirement applies to all Apparel, Footwear, Soft Home products, Hard Home products in packaging, and all Handbags, Accessories and Jewelry with hangtags, headers, or backer cards.

Account Setup and Contact Info

Upon receipt of this message, please **reach out to Avery Dennison to complete set up of an account**, as well as to schedule training on what to order, how to order, and how to apply the RFID hangtags / stickers.

- RFID hangtags and stickers for Belk will be printed in Avery Dennison service locations in China, India, Vietnam, Honduras, and Mexico
 - Many of you already have an established relationship with Avery Dennison for your retail and brand tags today, this will speed up the process

Hangtags/Stickers and Lead Times

You will find information below on the RFID hangtags and stickers you will be required to use (see chart below).

- There are three options for Supplemental RFID Tags / Stickers, and direction has been provided on which format to use on each type of product
- Belk has already negotiated prices for these with Avery Dennison, please note that there will be no further local discounting on these costs

- You will also find lead time and delivery information below by Country
 - It will be the Vendor's responsibility to plan RFID tag order timing to meet your production needs, using the delivery commitments that Avery Dennison has made
 - Note that there will be no MOQ per order, and Avery Dennison's production lead time will be 10 business days, plus transit time

Purchase Order Updates


Please begin work with your sourcing and buying partners for any Purchase Order updates that need to be made to account for this additional RFID hangtag / sticker.

It is important that you **reach out to Avery Dennison as soon as possible**, as they will share much more detailed information in the required Vendor training that they will facilitate. Belk will also be updating the Belk VBR with RFID requirements as well, look for an updated document online at belk.com, no later than 12/11. **Agent partners, please also share and review this communication with your Vendors.**
